1. 5:30 P.M. CALL TO ORDER

Mayor Monte Richardson called the meeting to order at 5:30 p.m.

2. INVOCATION AND PLEDGES OF ALLEGIANCE

Alderman Browning led all in prayer and pledges of allegiance.

3. ROLL CALL AND CERTIFICATION OF QUORUM

Present to-wit: Mayor Monte Richardson, Aldermen Wayne Browning, Derek Anderson, Margaret Kistler, and Joe Ed Lynn; thereby a quorum was established. Also present were City Attorney Charley Smith, City Administrator Lynn S. Roberts, and City Secretary Betty Hollon.

4. CONSIDERATION/ACTION TO ADOPT AGENDA

The motion was made by Alderman Browning and seconded by Alderman Anderson to adopt the agenda as presented. Motion carried unanimously.

5. APPOINTMENT OF MAYOR PRO-TEMPORE BY MAYOR

Mayor Richardson appointed Alderwoman Kistler to serve as Mayor Pro-Tempore.

6. APPOINTMENT OF ALDERMAN POSITION #5 AND ANY RELATED ACTION NECESSARY

Mayor Richardson recommended Douglas Lottridge to fill the vacancy of Alderman, Position 5. The motion was made by Alderwoman Kistler and seconded by Alderman Lynn that Mr. Lottridge be appointed to Position 5. During discussion Alderman Browning recommended having an election to fill the vacancy. Mayor Richardson called for a vote. Alderman Lynn, Kistler, and Anderson voted aye that Mr. Lottridge be appointed to fill the vacancy and Alderman Browning was opposed. Motion carried.

7. CONSIDERATION OF ORDINANCE PROHIBITING RESIDENTIAL STRUCTURES WITHIN ANY BUFFER ZONE DEFINED BY 30 TAC SECTION 309.13 (A) – (E) AND ANY RELATED ACTION NECESSARY

A motion was made by Alderman Browning and seconded by Alderwoman Kistler to adopt Ordinance 1349 – Amending Chapter 3 of the City Code of Ordinances by Adding Article 3.16 Regulating the Construction of Residential Structures within a Buffer Zone. Motion carried unanimously.
