1. 5:00 P.M. CALL TO ORDER

Mayor Joe Ed Lynn called the meeting to order at 5:00 p.m.

2. INVOCATION AND PLEDGES OF ALLEGIANCE

Alderman Wayne Browning led all in prayer and Pledges of Allegiance.

CONSIDERATION TO ADOPT AGENDA

Mr. Chad Eckelberg asked Council for funds to assist the Bellville Little League. Laura Smith, manager of Bell Oak Village Apartments, spoke to Council regarding connect & disconnect fees on utility bills.
