# MINUTES OF A REGULAR MEETING OF THE CITY COUNCIL

#### **SEPTEMBER 20, 2022**

## 1. 5:30 P.M. CALL TO ORDER

Mayor James Harrison called the meeting to order at 5:30 p.m.

#### 2. INVOCATION AND PLEDGES OF ALLEGIANCE

Wayne Browning led all in prayer and Pledges of Allegiance.

### 3. CERTIFICATION OF A QUORUM

Present-to-wit: Mayor James Harrison, Aldermen Garrett Dornon, Arlie Kendrick, Alderwoman Ashley Slater, and Betty Hollon; thereby a quorum was established. Also present was City Administrator Shawn Jackson, and City Secretary Rachael Lynch.

#### 4. CONSIDERATION/ACTION TO ADOPT AGENDA

The motion was made by Alderwoman Slater and seconded by Alderwoman Hollon to approve the Agenda of the Regular Meeting of September 20,2022, as presented. Motion carried unanimously.

## 5. CONSIDERATION TO APPROVE MINUTES OF PREVIOUS MEETING

The motion was made by Alderwoman Hollon and seconded by Alderman Kendrick to approve the Regular Meeting of August 16, 2022, and Special Meeting August 25, 2022, and Special Meeting September 06, 2022. Motion carried unanimously.

Richard Cantu had two complaints -one about an employee for posting a door hanging on his door regarding an NSF check and no being allowed to pay by check. His second complaint is regarding his trash not being picked up by Republic, four time in a five-week period.

Margie Lovell wanted to know what the status was regarding the Hacienda subdivision.

Shawn informed Council that Fall Cleanup will be the week of September 26<sup>th</sup>, notice is in their packet. Mosquito spraying will begin this week. Bids for the water well rehabs are scheduled to go out in November.
