MINUTES OF A REGULAR MEETING OF THE CITY COUNCIL

DECEMBER 20, 2022

1. 5:30 P.M. CALL TO ORDER

Mayor James Harrison called the meeting to order at 5:30 p.m.

2. INVOCATION AND PLEDGES OF ALLEGIANCE

Mayor Harrison led all in prayer and Pledges of Allegiance.

3. CERTIFICATION OF A QUORUM

Present-to-wit: Mayor James Harrison, Aldermen Garrett Dornon, Arlie Kendrick, Monte Richardson, Alderwoman Ashley Slater, and Betty Hollon; thereby a quorum was established. Also present was City Administrator Shawn Jackson, City Secretary Rachael Lynch, and City Attorney Luke Cochran.

4. CONSIDERATION/ACTION TO ADOPT AGENDA

The motion was made by Alderman Dornon and seconded by Alderwoman Slater to approve the Agenda of the Regular Meeting of December 20, 2022, moving Agenda Items 15 & 16 to be after Agenda Item 6. Motion carried unanimously.

5. CONSIDERATION TO APPROVE MINUTES OF PREVIOUS MEETING

The motion was made by Alderman Kendrick and seconded by Alderwoman Hollon to approve the minutes for the Regular Meeting of November 15, 2022, with changes to # 8 from Alderman Hollon to Alderwomen Hollon and # 9 Change Dr. Cooper to Dr. Coopersmith. Motion carried unanimously.

Motion carried unanimously.

14. DISCUSSION AND POSSIBLE ACTION REGARDING APPOINTING A COMMITTEE TO REVIEW AND APPROVE CHANGE ORDERS ON THE POLICE DEPARTMENT BUILDING PROJECT AND SETTING A MAXIMUM AMOUNT OF FUNDS WHICH CAN BE EXPENDED BY THE COMMITTEE WITHOUT CITY COUNCIL APPROVAL.

A motion was made by Alderman Dornon and seconded by Alderwoman Hollon to approve appointing a committee to review and approve change orders on the Police Department Building Project and setting a maximum amount of funds which can be expended by the Committee without City Council Approval. The committee consist of the Chief of Police, City Administrator, Alderman Kendrick and Alderwomen Slater with the maximum amount of \$40,000. Motion carried unanimously.

Agenda Item # 15 and # 16 was moved, discussed, and voted on after Agenda Item #6.

15. DISCUSSION AND POSSIBLE ACTION TO APPROVE A RESOLUTION AUTHORIZING PUBLICATION OF NOTICE OF INTENTION TO ISSUE CERTIFICATES OF OBLIGATION IN THE MAXIMUM PRINCIPAL AMOUNT OF \$5,000,000 FOR ALL OR ANY PART OF THE COSTS ASSOCIATED WITH (i) THE CONSTRUCTION OR ACQUISITION OF AND/OR IMPROVEMENTS TO CITY PROPERTY, INCLUDING THE DESIGN, ACQUISITION, CONSTRUCTION, AND EQUIPMENT OF THE NEW POLICE STATION AND REHABILITATION OF THE EXISTING POLICE STATION, (ii) THE CONSTRUCTION OR ACQUISITION OF AND/OR IMPROVEMENTS TO THE CITY'S WATER AND WASTEWATER

SYSTEM, AND (iii) THE COST OF PROFESSIONAL SERVICES INCURRED IN CONNECTION THEREWITH.

A motion was made by Alderman Dornon and seconded by Alderwoman Slater to approve A RESOLUTION AUTHORIZING PUBLICATION OF NOTICE OF INTENTION TO ISSUE CERTIFICATES OF OBLIGATION IN THE MAXIMUM PRINCIPAL AMOUNT OF \$5,000,000 FOR ALL OR ANY PART OF THE COSTS ASSOCIATED WITH (i) THE CONSTRUCTION OR ACQUISITION OF AND/OR IMPROVEMENTS TO CITY PROPERTY, INCLUDING THE DESIGN, ACQUISITION, CONSTRUCTION, AND EQUIPMENT OF THE NEW POLICE STATION AND REHABILITATION OF THE EXISTING POLICE STATION, (ii) THE CONSTRUCTION OR ACQUISITION OF AND/OR IMPROVEMENTS TO THE CITY'S WATER AND WASTEWATER SYSTEM, AND (iii) THE COST OF PROFESSIONAL SERVICES INCURRED IN CONNECTION THEREWITH with the changes to include City streets, gas and related improvements, and remove language related to rehabilitation of the existing police station. Motion carried unanimously.

16. DISCUSSION AND POSSIBLE ACTION TO APPROVE A RESOLUTION EXPRESSING INTENT TO FINANCE EXPENDITURES TO BE INCURRED FOR THE DESIGN AND CONSTRUCTION OF THE CITY'S NEW POLICE STATION.

A motion was made by Alderman Dornon and seconded by Alderwoman Slater to approve A RESOLUTION EXPRESSING INTENT TO FINANCE EXPENDITURES TO BE INCURRED FOR THE DESIGN AND CONSTRUCTION OF THE CITY'S NEW POLICE STATION with the addition of acquisition of land and construction cost. Motion carried unanimously.

17. DISCUSSION AND POSSIBLE ACTION REGARDING AUSTIN COUNTY CONDUCTING THE MAY 2023 GENERAL ELECTION.

A motion was made by Alderwoman Hollon and seconded by Alderman Kendrick to approve Austin County conducting the City May 2023 General Election. 4-1 Alderman Dornon voted against.
