# MINUTES OF A REGULAR MEETING OF THE CITY COUNCIL

### AUGUST 19, 2025

# 1. 5:30 P.M. CALL TO ORDER

Mayor Arlie Kendrick called the meeting to order at 5:30 p.m.

## 2. INVOCATION AND PLEDGES OF ALLEGIANCE

Council Member Richardson led all in prayer and Mayor Kendrick led the Pledges of Allegiance.

## 3. CERTIFICATION OF A QUORUM

Present-to-wit: Mayor Arlie Kendrick, Council Members Monte Richardson, Robert Hancock, Garrett Dornon, John Conley II, and Betty Hollon; thereby a quorum was established. Also, present was City Secretary Rachael Lynch, City Administrator Shawn Jackson and City Attorney Luke Cochran.

#### 4. CONSIDERATION/ACTION TO ADOPT AGENDA

The motion was made by Council Member Dornon and seconded by Council Member Hollon to approve the Agenda of the Regular Meeting of August 19, 2025, as presented. Motion carried unanimously.

### 5. CONSIDERATION TO APPROVE MINUTES OF PREVIOUS MEETING

The motion was made by Council Member Hollon and seconded by Council Member Conley to approve the minutes for the Regular Meeting July 15, 2025. Motion carried unanimously.

6. CITIZEN'S FORUM (Any public comment that is made on an item that is not on the posted final agenda will only be heard by the City Council. No formal action, discussion, deliberation, nor comment will be made by the Council.)

Rachel Lucky has concerns regarding the Horton house. Clare Hultberg has some concerns over Clark Park Football field rentals.

# 7. REPORT OR REQUEST(S) FROM CITY ADMINISTRATOR/DEPARTMENT HEADS

Shawn informed Council that the bids for the street project are out and are being advertised. They will be opened on September 2<sup>nd</sup> and approved by Council at the regular September meeting. Construction is scheduled to start in December.

The Main Street water line replacement project has been completed, except for the grouting of the abandoned lines. Grouting will be completed in the week of the 18<sup>th</sup>.

We are looking at scheduling a Budget Workshop for the week of August 25. Under the new regulations, a three-business day notice is now required for all meetings regarding the budget and tax rate.

Council Member Hollon inquired about the library being closed on a Saturday and making sure that we are posting that they will be closed in advance. She also inquired about when council will be receiving the preliminary budget. She also mentioned tree trimming and potholes.

Council Member Hancock would like to see less weeds and more mulch added at Clark Park and less weeds at the mini park.

Council Member Dornon would like the Capital Project list – to possibly include a third column for timelines that have gone over the projected completion date or revised the projected completion date.
