1. 5:00 P.M. CALL TO ORDER

Mayor Joe Ed Lynn called the meeting to order at 5:00 p.m.

2. INVOCATION AND PLEDGES OF ALLEGIANCE

Alderwoman Donna Jacob led all in prayer and Pledges of Allegiance.

3. CERTIFICATION OF A QUORUM

Present-to-wit: Mayor Joe Ed Lynn, Aldermen Douglas Lottridge, Clay Kistler, John Moore, Alderwomen Cassie Janish and Donna Jacob; thereby a quorum was established. Also present were City Administrator Shawn Jackson, City Attorney Charley Smith and City Secretary Betty Hollon.

CONSIDERATION TO ADOPT AGENDA

The motion was made by Alderman Lottridge and seconded by Alderwoman Janish to adopt the Agenda for the Regular Meeting of September 18, 2018 as presented. Motion carried unanimously.

CONSIDERATION TO APPROVE MINUTES OF PREVIOUS MEETINGS

The motion was made by Alderman Lottridge and seconded by Alderman Kistler to approve the Minutes of the Special Meeting of August 14, 2018, Minutes of Regular Meeting of August 21, 2018 and Minutes of Special Meeting of September 4, 2018 as presented. Motion carried unanimously.

CONSIDER AND APPROVE AN ORDINANCE AUTHORIZING THE ISSUANCE OF CITY OF BELLVILLE, TEXAS, GENERAL OBLIGATION REFUNDING BONDS, SERIES 2018; SETTING CERTAIN PARAMETERS FOR THE BONDS; AUTHORIZING THE PRICING OFFICER TO APPROVE THE AMOUNT, THE INTEREST RATE, PRICE, AND TERMS THEREOF AND CERTAIN OTHER PROCEDURES AND PROVISIONS RELATING THERETO

The motion was made by Alderwoman Janish and seconded by Alderwoman Jacob to adopt the 2018-2019 Bellville Economic Development Corporation Budget as presented. Motion carried unanimously.

12. CONSIDERATION OF APPOINTMENT TO BELLVILLE ECONOMIC DEVELOPMENT CORPORATION BOARD AND ANY RELATED ACTION NECESSARY

Mayor Joe Ed Lynn recommended Ric Flores to fulfill the unexpired term of Delwin Rettig. The motion was made by Alderman Lottridge and seconded by Alderman Moore to appoint Ric Flores to the Economic Development Corporation Board. Motion carried unanimously.

The motion was made by Alderman Moore and seconded by Alderwoman Jacob to approve the amended Appendix A (Fee Schedule) to the Code of Ordinances. Motion carried unanimously.

The motion was made by Alderman Lottridge and seconded by Alderman Moore to adopt the 2018-2019 Fiscal Year Budget as presented. Mayor Lynn called for the vote. Voting aye were Alderman Lottridge, Kistler, and Moore and Alderwoman Janish. Opposed was Alderwoman Jacob. Motion carried.
